### **Proposed Ravenstonedale Parish Local History Group**

The meeting was held to assess the degree of interest & involvement there might be within the parish for a local history group and to work out from that, the way forward. Approximately fifteen people attended including Elspeth Griffiths and Diane Elphick from Sedbergh History Society. The meeting was chaired by Caroline Morris.

It is thought that an active Local History Group would be a core facility for the proposed Community and Heritage Centre to be housed in the former chapel. History is all encompassing and starts from yesterday, each person may have a particular aspect of research which interests them and this eventually will build up a rich and varied picture of the life in this parish over its long past. The prospect is an exciting one.

Following on from various queries The Parish Clerk explained the progress in purchasing the building. A 'terms of sale' document has finally been drawn up and the Council is now at the stage of negotiating the finer details. In the meantime the Parish Council has and is carrying out as much as it can in preparation for taking over the High Chapel e.g. feasibility study, structural survey etc;
